

## Terms and Conditions

Please read these Terms and Conditions (the “**Terms**”) carefully. You will be legally bound by these Terms from the time you submit an entry for the **Bisto and Country Range Care Caterer of the Year 2019** promotion (the “**Promotion**”).

### The Promoter

1. Premier Foods Group Limited of Premier House, Centrium Business Park Griffiths Way, St. Albans, United Kingdom, AL1 2RE is the “**Promoter**”.

### Eligibility

2. The Promotion is open to professional caterers, aged 18+ who are residents of the United Kingdom or Republic of Ireland and employed or working as a caterer for a care home in the United Kingdom or the Republic of Ireland. This promotion excludes the agents and employees of the Promoter and its group companies, the families of such agents and employees, or anyone professionally connected with the Promotion or its administration.
3. Entrants must seek their employer’s consent prior to entering this Promotion.
4. Internet access and a valid email address required.
5. Entrants may need to provide proof of name, age, address, purchase and employment to validate that they meet the entry requirements and can accept any prize awarded to them.

### How to Enter

6. The Promotion will open for entries at 9.00am on 1 April 2019 (the “**Opening Time**”) and will close at 5pm on 2 August 2019 (the “**Closing Time**”). The period from the Opening Time and ending at the Closing Time is the “**Promotion Period**”.
7. To enter, entrants will need to, during the Promotion Period and by no later than the Closing Time:

(b) Create one dessert featuring one of the following Foodservice County Range products:

(c) Visit [www.premierfoodservice.co.uk](http://www.premierfoodservice.co.uk) and download an entry form; and

(d) Complete the entry form and submit it with recipes and photographs of their main meal and dessert, the cooking & preparation method and list of equipment used, either by email to [Sarah.Robb@premierfoods.co.uk](mailto:Sarah.Robb@premierfoods.co.uk) or, by post to Sarah Robb at Premier Foods Group Ltd, Premier House, Centrium Business Park, Griffiths Way, St Albans, AL1 2RE.

8. Cost of ingredients for each dish must not exceed £2.25 for one portion. Please retain proof of purchase.
9. Entries submitted by email and by post will need to be received by no later than the Closing Time. Any entries received after the Closing Time will be disqualified.
10. Each entrant may enter the Promotion once. Use of multiple email addresses to submit multiple entries will not be accepted. Entries made through agents, third parties, organised groups or any entry duplication method will not be accepted.

### **Finalists**

11. Four finalists (the “**Finalists**”) will be selected from all eligible entries, based on the most creative and appealing main meal and dessert combinations and which would be suitable to serve in a care home. The Finalists will be selected by a panel of judges which will include at least one independent member.
12. Each of the Finalists will win a professional knives set (including a minimum of three knives) worth £200.00 (the “**Finalist Prize**”).
13. The Finalists will be notified that they are finalists in the live final (the “**Live Final**”) by email using the contact details provided in the Finalist’s entry form (the “**Notification**”). Finalists will also be asked to confirm the delivery address for delivery of the Finalist Prize. Finalists will be contacted by no later than 10 August 2018. Entrants who are not selected as a Finalist will not be notified. Please note that Finalists will be contacted by email irrespective of whether they submitted their entry by email or by post.
14. If you are a Finalists you will have 7 days from the date the Notification is sent to confirm that you can compete in the Live Final and can accept the Finalist Prize. If you do not provide confirmation by this date or, are unable to compete in the Live Final or accept the Finalist

Prize for any reason, then the Promoter shall reserve the right to select an alternative Finalist from all remaining entries, using the criteria set out in clause 11 and the alternative Finalist will compete in the live final and shall win the Finalist Prize.

15. The Finalist or, an individual aged 18 or over nominated by the Finalist, will need to be available at the Finalist's confirmed delivery address to accept and sign for delivery of the Finalist Prize.
16. The Finalists will be provided with 3 star hotel accommodation in St Albans (or within an 10 mile radius of St Albans), in a standard double or twin room (with breakfast for one included) for 11 September 2018 (the evening before the Live Final). The Promoter will refund any expenses incurred by the Finalist for travel expenses incurred to participate in the Live Final and / or for accommodation for the evening of the Live Final, up to a total of £200. Finalists will be required to provide receipts in order to obtain a refund for their expenses. Finalist will be refunded with the total of their expenses, up to a maximum total of £200, within 7 working days from the date the Promoter receives the Finalist's valid receipts and bank account details.

### **The Live Finals and the Winner**

17. The Live Final will take place at 9am on 12 September 2018 at Premier Foods Group Ltd, Premier House, Centrium Business Park, Griffiths Way, St Albans, AL1 2RE, where the Finalists will have 90 minutes to prepare and cook three portions of their main meal and three portions of their dessert dishes.
18. A panel of judges, including one independent judge will be present at the Live Final and will select one Winner from the Finalists. The Finalist whose combination of dishes best meets the criteria set out in clause 11 and is judged the best on taste, texture, aroma and appearance will be selected as the Winner.
19. The Finalists will be required to bring their own ingredients to the Live Final for each of their dishes (a total of 6 portions) and plates to present their dishes on. The maximum cost for ingredients, per portion, set out in clause 8 will apply.
20. The kitchen in which Finalists will be cooking in at the Live Final provides basic cooking facilities. If a Finalist requires specialist equipment (such as a thermal mixer) to produce their dishes, then they will need to bring such equipment to the Live Final. Finalists can contact the Promoter to check what equipment will be available at the Live Final.
21. When attending the Live Final, Finalists should ensure that they comply with any site health and safety rules, codes of conduct and any other instruction provided by employees at the site.

### **The Winner's Prize**

22. The Winner will win:
  - (a) one £250 John Lewis voucher for themselves (the "**Winner's Prize**");
  - (b) and one £1000 John Lewis voucher for the care home that the Winner is employed by / works at (the "**Care Home's Prize**")
23. The Winner's Prize will be given to the Winner at the Live Final.
24. The Care Home's prize will be delivered by post to the care home, for the attention of a member of management. The Care Home's Prize will be delivered to the care home within 30 days of the Live Final taking place.
25. The voucher supplier's terms of use will apply to the Winner's Prize and the Care Home's Prize.

26. A representative of the care home, aged 18 or over will be required to sign for delivery of the prize at the care home.

### **Prizes Conditions**

27. There is no cash alternative to any prizes. The Promoter reserves the right (but is not obliged) to substitute a reasonably equivalent alternative prize, of equal or greater value, should circumstances make this necessary.
28. Prizes are not negotiable or transferable.

### **Data Protection and Marketing**

29. All entries and any accompanying material submitted to the Promoter will become the property of the Promoter on receipt and will not be returned. By submitting an entry and any accompanying material, each entrant agrees to:

(a) assign to the Promoter all intellectual property rights in their entry and any accompanying material with full title guarantee; and

(b) waive all moral rights

in and to their entry and otherwise arising in connection with their entry to which the entrant may now or at any time in the future be entitled under the Copyright, Designs and Patents Act 1988 as amended from time to time and under all similar legislation from time to time in force anywhere in the world. Each entrant agrees that it shall execute any document or instrument necessary to give effect to any assignment, grant of rights or waiver referred to in this clause 29.

30. By entering the Promotion, each entrant agrees that any personal information provided by them with their entry may be held and used by the Promoter or its agents and its suppliers for the purpose of administering the Promotion. Entrants also acknowledge and agree that, in the event that they are selected as a Finalist and / or a Winner then, their personal data as described in clause 31 may be used for the purpose set out in clause 31.
31. The Finalists and the Winner may be required to take part in non-paid publicity or advertising relating to the Promotion, which may include having their photograph taken for promotional and press purposes. Entrants agree that, should they become a Finalist and / or a Winner in this Promotion, that the Promoter may use their name, image and county of residence to announce them as a Finalists and / or the Winner of the Promotion and for any other purpose of promoting the Promotion, the Promoter's business and business activities.

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the Finalists and / or the Winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking part in the Promotion or taking up any prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

## **General**

34. It will be the entrants' and Finalists' responsibility to ensure that their entries comply with all applicable food regulatory and food safety laws.
35. Any entries that do not comply in full with these Terms and the applicable terms set out in this clause will be disqualified.
36. Any decision of the Promoter as to eligibility to take part in the Promotion or the result of the Promotion will be final and no correspondence or discussion will be entered into. The Promoter accepts no responsibility for entries that are incomplete, delayed, lost, damaged or unreadable whether due to failure or non-availability of the website, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind, or the submission of incomplete information or any other reason.
37. The Promoter reserves the right to delay, postpone or cancel the Promotion in the event of circumstances outside its reasonable control, which it considers necessary.
38. The Promotion and these Terms are subject the laws of England and Wales. Any disputes must be referred to the English courts.
